### **Open Forum and Announcements**

**New Members:** The new members were approved at the March 11<sup>th</sup> meeting; however, one of the newly selected member's could not fulfill the residence requirement of the position; therefore, an alternate was selected.

### **Facility Project Updates**

**Mabel Lee Fields:** The Project is moving along. There was a one week delay because the contractor submitted an alternative drainage system. The new Musco lights have been delivered. There will be a blue emergency phone near the support building, as requested by University Police. There is also an emergency phone approximately 150 feet away, but on the outside of the fence, from where the new one is being placed. An old house foundation was found when excavating the site. The foundation was removed at an additional cost. The substantial completion date has been moved to July 6. Stan Campbell sent the synthetic turf research compiled by Campus Recreation staff members to ASUN.

**Breslow Ice Center:** Stan Campbell, Bill Goa, and representatives from Lincoln Parks & Recreation and the DLR Group toured three ice centers in the Minneapolis area on March 24. The trip was valuable, as several good ideas were gathered from discussions from the rink operators. A site has still not been determined. There is another meeting tomorrow with UNL, City and University Foundation officials concerning site selection. It appears as if the closest site to campus would be the most costly.

**Campus Recreation Indoor Facilities Master Plan:** There is a meeting with the newly elected ASUN officers (Emily Zimmer, Trevor Nieveen and Katie Madsen), David Solheim, Gregg Gifford, Dr. Guest, Bill Goa and Stan Campbell scheduled for Friday, March 28 at 9:30 AM to talk about potential renovation to the Univ. Health Center along with the Indoor Campus Recreation Facilities Master Plan. Stan and Dr. Guest are trying to gage the level of interest by ASUN in these projects
