I. Open Forum and Announcements

- A. Update of open CRAC Representative positions – Two new CRAC members have been appointed by ASUN. Ryan Hoffman and Steve Scharf, were appointed representing Residence Halls and Off-Campus respectively.
- B. Campus Wellness ad hoc Committee Update – The committee is still in the researching stage of what changes need to be made to the existing referendum and Mallory Wittstruck encouraged CRAC members to give any advice they may have.
- C. A Leadership Training Center consultant will be on campus Tuesday, Nov. 10 – Emily Ives, Pat Macy, Mallory Wittstruck, Kristen Ost diek, Alex Weingarten and Pete Maslowski indicated they would attend the 4:30 PM Leadership Training Center consultant meeting.
- D. Intramural Sports Football Pick'em sheets were distributed. The winner will be announced at the Nov. 17 meeting.
- E. CRAC Members Studying Abroad in Spring – Please let Mark Powell know ASAP if you may have a time conflict with the meeting time or will be gone Spring Semester of 2010.

II. Committee Reports

- A. Instructional Programming and Staff Development – No report
- B. Intramural and Extramural Sports –  
The ACIS Regional Flag Football Tournament is being hosted by UNL on Nov. 14-15. Teams will be playing at Cook Pavilion, Fleming Fields and Mabel Lee Fields.

With more than 1600 teams participating in intramural sports this past year, Intramural and Extramural Sports has had to hire more officials than planned. The increase in participation may present budget problems.

- C. Membership Selection and Rules – Will meet in January with applications available at GET REC'd and interviews in February
- D. Outdoor Adventures - Approximately fifty percent of the Challenge Course reservations were cancelled this fall because of the bad road conditions from rain.
- E. Social – We are planning a Holiday party with Secret Santas. Mallory Wittstruck suggested having a CRAC team competing in Battleship.
- F. Sport Clubs, Youth Activities, and Aquatics - Professionals evaluated the Campus Rec pool and the Mabel Lee pool. The Mabel Lee Hall pool is in very bad shape with a

minimum anticipated cost of \$500,000 to fix the problems. The drain problem must be fixed by March if the pool is to be passed for certification. The Campus Rec pool doesn't have as many problems as Mabel Lee, but still needs several areas fixed. Aquatics will look into sharing the Campus Recreation pool for classes and lessons, possibly looking into renting other local pools close to campus.

III. Facility Updates

- A. Wiese Property Update – Most of the paperwork has been completed to move the sale forward with the total cost being \$600,000. The Board of Regents is expected to vote on the purchase at its December 11 meeting. If approved, the paperwork is expected to be completed by the end of 2009,
- B. Mabel Lee Pool Maintenance Update – The full extent of the problems won't be known until we receive the consultant's report and repairs are started.
